Terms of Association

- 1) That Mewar Univ is an autonomous body set up by the Govt. of Rajasthan through Act. No. 4 of 2009 passed by the Rajasthan Legislative Assembly (Govt. of Rajasthan). The Univ is recognized by the UGC u/s 2(f) of UGC Act with powers to confer degrees u/s 22(1) of the UGC Act, 1956 vide their letter no. F.9-15/2009(CPP-I) dated 30th March, 2009. This is the only private and self-financed Univ in Rajasthan which is also approved by the UGC u/s 12B of the UGC Act vide their letter No. F.9-15/2009 (CPP-I/PU) dated 15th October, 2018. The Univ is also NAAC accredited. The Univ furthermore has approval from concerned statutory regulatory authorities such as the Bar Council of India (BCI), Pharmacy Council of India (PCI), All India Council of Technical Education (AICTE), National Council of Teacher Education (NCTE), & member of the Association of Indian Universities.
- **2)** That through this MOU the Party of 1st Part Authorizes the Party of 2nd Part to act as a Admission following programs:

S.No.	Course's	Duration
1.	M.B.A. in Safety Management	2 Year's
2.	P.G. Diploma in Safety Management	1 Year
3.	B.Sc in Safety Management	3 Year's
4.	B.Sc (Hon's) in Safety Management	4 Year's
5.	Diploma in Safety Management	3 Year's

- **3)** That through this MOA the Party of 1^{st} Part Authorizes the Party of 2^{nd} Part to act as an admission counselor for all programs of the University as notified on the website of the University.
- **4)** 1st Party authorizes the 2nd Party to use its name for official purposes (limited to training and admission only) till the valid contract period.

Terms of Implementation

- 1) Party of 2nd Part will not ask for or collect any amount of service charges/capitation fee from the students such practice is strictly prohibited. In case it is observed or reported, the same will be treated as un-lawful activity solely at their risk and Mewar University will not be responsible for the same and this authorization will be terminated without giving any notice.
- **2)** All fess will be paid only by DD drawn in favour of Mewar University payable at Chittorgarh or online transferred to Mewar University bank account. No cash will be collected on behalf of Mewar University from any student and their parents.

- 3) 1st Party agrees that it will transfer the 2nd party's due amount in lieu of the student/s' admission to the 2nd Party within 30 days of receipt from the student/s.
- **4)** All the fees along with their admission documents need to be submitted to the University and minimum 10 days the University will take for processing the confirmation post verification of the authenticity and eligibility of the documents.
- 5) All fees must be paid to Party of 1st Part in lump-sum full amount
- 6) The 1st Party agrees that post completion of the registered course by the student/s; it will issue the certificate/ diploma/ degree within the stipulated timeframe to the student/on successful completion of exam by the student concern.

Duration of Association & Renewal of the agreement

- 1) This MOU shall stand valid for Six academic sessions in terms of intake of the students but the students admitted through the agreement shall stand valid up to completion of their courses
- **2)** This MOU may be renewed on mutual agreement by both the parties for which if agreed by both the parties.

Terms of finances

- 1) For All Post Graduate Courses fees will be charged Rs. 18000/- per year per student and it will be fully paid at the time of admission and course duration is One Year.
- 2) For All Master (MBA) Courses fees will be charged Rs. 45000/- per year per student and it will be fully paid at the time of admission and course duration is Two Years.
- 3) For Bachelor and Honor's Courses fees will be charged Rs. 28000/- per student and it will be fully paid at the time of admission and course duration is Three & four Years.
- 4) For All Diploma Courses fees will be charged Rs. 20000/- per student and it will be fully paid at the time of admission and course duration is Three Years.
