Agenda Item No. 5: Inauguration of Mewar University Hospital.

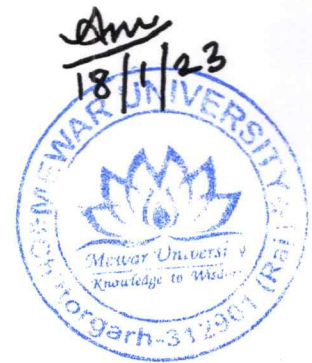
Resolution: Mewar University hospital is ready for official inauguration. It is resolved to organize Inauguration of Mewar University Hospital in the coming month at a convenient date.
