### 16.Multidisciplinary / interdisciplinary

Mewar University has been offing various interdisciplinary courses/programmes to the students of the university. The implementation of NEP-2020 has paved the way for institutions to transform themselves into holistic multidisciplinary institutions. The university has approached the integration of humanities and science. The students from science, engineering and technology areoffered various value-added courses in a humanities discipline and students from humanities backgrounds can opt for technical valueadded courses.

Mewar university has been offering flexible and innovative curricula that include credit-based courses and projects in the areas of community engagement and service, environmental education, and valuebased education towards the attainment of holistic and multidisciplinary education. Students from the Department of Agriculture has to complete Rural Agricultural Work Experience (RAWE) training that enables the students to gain rural experience, gives them confidence and enhances on-farm problem-solving abilities in real-life situations, in coordination with producers and consumers.

With the implementation of NEP-2020, Mewar University plans to offer programmes that enable multiple entries and exits at the end of the first, second and third years of undergraduate programmes. The university has plans to engage the faculty members and research scholars in research work that are beneficial to society e.g. A team of students and faculty members are working on the development of Bioplastic from fruit extracts.

17.Academic bank of credits (ABC):

The candidates who have appeared at the End Term Semester / Annual

Examinations shall be issued the Grade Sheets / Statement of Marks through the Office of Controller of Examinations, necessarily mentioning the grade/marks or both in individual courses/subjects along with the award of SGPA (Semester Grade Point Average) and CGPA (Cumulative Grade Point Average) / total obtained out of maximum marks; by the permission to issue such results by the Hon'ble Chairperson / Chancellor. The Marks and grade sheet for the final semester for successful candidates leading to the award of degrees shall display all the previous individual semester/years performances (SGPA / Total obtained marks) along with the current and cumulative shall be issued through the Controller of Examination under intimation to the Registrar of the University. All those who have successfully completed the programmes by passing all the courses, earning the requisite total Credits, the required minimum grades / minimum percentage, the project /training internship, and all requirements as per the ordinance and scheme of the respective programme shall be eligible for the award of degree in the subsequent University Convocation. The Degree shall be issued under the name and sign of the Hon'ble Chairperson (Chancellor) and by the President (Vice Chancellor) of the University under his sign and seal. They may be issued the provisional degree certificate which may be valid till the subsequent University convocation.

#### **18.Skill development:**

Mewar university has been working to strengthen the vocational education and soft skills of students. The university has also applied for approval of NCVET under the dual category which means that the university will be approved as awarding body as well as an assessment agency. Also, the university has undertaken many government projects in the field of vocational education and trained thousands of students in this field. Also, the university regularly conducts soft skills training sessions. Further, the university plans to implement NSQF-aligned vocational courses such as B.Voc in many streams.

To promote vocational education, the university has conducted various programs in collaboration with various state skill development centres such as Rajasthan, Uttar Pradesh, Odisha etc. The university has adopted Universal human values as one of the subjects as mandated by AICTE which includes the development of humanistic, ethical, Constitutional, and universal human values of truth (Satya), righteous conduct (dharma), peace (Shanti), love (prem), nonviolence (ahimsa), scientific temper, citizenship values, and also life-skills etc. Furthermore, regular mentorship is provided to all the students on these topics by qualified teachers. Vocational courses are a core part of the curriculum of the university. For example, an agriculture student will do a vocational course on food processing, similarly, a mechanical engineering graduate has to do a course on 3D printing to add the required skills. University regularly involves various industry veterans to train our students in a specific field. At current we are offering it on campus. Further, the university will offer it in online mode, as we get the approval for Open and Distance Learning (ODL) mode. The university is planning to offer various courses on AI, Block Chain, Cloud Computing, Quantum Computing, Data Analytics, Big Data, Machine Learning, and electric vehicles in future. As per NEP-2020, the university has prepared itself to offer skill development courses along with regular courses through certificates, minor degrees etc.

**19.**Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

Mewar University is offering undergraduate and postgraduate courses in Indian Languages in various programmes e.g. D.El.Ed, B.Ed. etc. UG programme in Agriculture, Horticulture, Forestry etc includes different subjects like the Agricultural Heritage of India, Medicinal and Aromatic Plants, Ethnobotany etc that are being taught in dual language.

All the faculty are motivated to teach in bilingual mode (English and vernacular). University is organizing classes for foreign students to teach them the Hindi language and behavioural classes are organised to make them understand the regional and Indian languages, culture and traditional values. Mewar University offers professional programmes, in both Hindi and English especially in the first year so as to get them acclimatized. Mewar University is conducting courses related to Indian Culture in Dance (Odissi), Vocal Music (Hindustani), Instrumental Music (Flute, Sitar, Tabla etc) etc. Courses on Indian traditions like Yoga, painting, astrology, Vastu etc are also being offered at various levels. The University admits students from different countries like Nigeria, Nepal, Uganda, etc and from almost all the states/union territories of India through special schemes of Ishan Uday scheme (for students of North Eastern States). The students from Jammu, Kashmir and Ladakh are being admitted under the scheme of the Army Welfare Education Society (AWES) as part of Sadbhavana. Mewar University is sponsoring 50 percent of fees for these students.

#### **20.**Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

Mewar University has always been proactive to transform its curriculum towards Outcome-based Education (OBE). Since 2015, there

have been major changes in the field of higher education. The major shift is related from teacher-centricity to learner-centricity which means the focus is on what the learner should learn and to what extent he has learnt and learning is measured in terms of to what extent a specified outcome has been attained by the student. Keeping this in mind, Mewar University has implemented Outcome-based Education (OBE) in its various programmes. Programme outcomes, Programme Specific Outcomes and Course Outcomes are defined and by using the Anderson-Bloom taxonomy table, these outcomes are measured as well. In an effort to capture Outcome-based education in teaching and learning practices, Mewar University has made it mandatory for all courses to have course outcomes defined and at the time of instructions in classes and at the time of assessment, the question paper is designed in such a way to cover all the course outcomes. The attainment is then calculated using AB Table and based on the attainment percentage of a particular CO, the quality loop is closed. Further, the COs are mapped to POs and PSOs as well. Mewar University has taken many initiatives in order to promote OBE such as training its faculty members in OBE, and workshops on the implementation of OBE in view of NEP-2020. Also, regular seminars/workshops are conducted to familiarize the faculty members with various aspects of the National Education Policy 2020.

#### **21.Distance education/online education:**

Mewar University uses Information Communication Technology in teaching along with regular offline teaching. The teachers use various ICT tools like PowerPoint Presentations, Google Classroom, ICT-enabled Classroom, MS Teams, Cisco Webex, Gnomio, WordPress, smartboards, Google Forms, MS Forms, etc. The university has a wellstructured infrastructure and is fully equipped with the IT facilities like computer systems, smart classrooms, a wi-fi campus, high-speed LAN, a recording studio, etc. The university has a license for Office365, and faculty members and students are registered users of the same which provides all the facilities associated with Office365. The faculty members of the University have been practising blended learning in the classes. Students are given assignments and quizzes online, presentations are taken offline as well as on online mode, and teachers record their lectures and share the link with the students. The university motivates the faculty members and students to do courses online on NPTEL SWAYAM, Coursera etc. The credits earned by the students are added to the student's credits earned at university examinations.

Mewar University's commitment to providing high-quality education is evident in the design and implementation of its programs. The university's curriculum is tailored to meet the developmental needs of the local, national, regional, and global communities.

To ensure that the curriculum is relevant and up to date, the university has set up a well-structured Board of Studies (BOS) for each department. The BOS is chaired by the Dean of Faculty and includes the Head of Department (HOD), internal faculty members, and external members from academia, industry, and alumni. This diverse group of stakeholders collaborates to develop and recommend a curriculum reviewed and approved by the Academic Council.

In addition, the university values feedback from students, parents, employers, alumni, and faculty members, which is used to update the curriculum regularly. The curriculum includes shortterm training programs and six-month internships, which provide practical experience to students. Value-added courses are also included to promote the overall academic development of students.

The university addresses local and regional needs by defining program-specific outcomes and course outcomes for each program. The course outcomes help students understand the objectives of the course and improve their learning levels.

To ensure that the curriculum remains relevant, the university has a policy of revising it every two years or whenever necessary. This policy ensures that the university's curriculum remains up-todate and relevant to the needs of the changing times.

Mewar University offers a wide range of courses that address crosscutting issues, including professional ethics, gender studies, human values, environment, and sustainability. The university is committed to promoting human values, human rights, gender equity, professional ethics, environmental conservation, and sustainable development among its undergraduate and postgraduate students, and research scholars. Most of the courses offered by the university incorporate these concerns into their curriculum.

The university's programs also include specific courses related to the environment, such as M.Sc. in Environmental Science, MTech. in Renewable Energy, and MTech. in Environmental Engineering. Furthermore, professional ethics courses are included in programs like MBA (MASTER OF BUSINESS ADMINISTRATION) in Corporate Governance, Values, and Ethics, B.Sc. in Agriculture in Human Value and Ethics, and Bachelor of Pharmacy in Pharmaceutical Jurisprudence.

Additionally, the syllabus of certain courses, such as MBA in Entrepreneurship Development and BBA (BACHELOR OF BUSINESS ADMINISTRATION) in Industrial Law, includes content related to gender equity. The university provides its students with a holistic education that incorporates these important cross-cutting issues into their learning experience.

#### 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

Mewar University assesses the learning levels of the students at various stages of the programmes. The student is enrolled in, wherein at the beginning of a unit, topics are allotted to the students for, Chart/Model, Presentation, and Assignment preparation. Students are adjudged as slow or advanced learners on the basis of their performance in assignments, charts, presentations, and internal assessments. Afterwards remedial classes, mock tests, etc., are arranged for slow learners. The teachers and counselors give personal attention to the slow learners. Student progress reports are kept and shared with their parents and guardians.

On the other side, the university also identifies, the advanced learner. The University arranges competitive classes i.e. GATE, CAT, UGC-NET, JET(Agriculture), and other competitive exams for advanced learners. The students are also encouraged to participate in various curricular activities. The University organizes various activities like quiz contests Management activities, etc. for the slow and advanced learners to motivate them and help them excel in all fields. Advanced learners are also engaged in research activities with faculty members of the concerned department.

#### 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problemsolving methodologies are used for enhancing learning experiences

The university has been following students centric methods, such as experiential learning, participative learning, and problemsolving methodologies for enhancing learning experiences. The Mewar University implements a two-way Teaching Methodology that helps students boost their confidence, and improve listening, writing, and public speaking skills. Since students vary in their ability to comprehend and absorb the subject knowledge uniformly, the teaching methodology adopted by the university helps in achieving better learning outcomes. The teacher facilitates learning by allowing each student to comprehend at their personal level by ensuring their involvement in-class activities to absorb and grasp information at their own pace. Experimental learning is practiced in the form of Lab activities, short-term training, internship, and industrial and field visits. Students are given problems in the assignments, and case studies in which they have to utilize their analytical skills to solve them. Various problemsolving methodologies such as group discussion, listing possible solutions to a problem at hand, and brainstorming is being implemented in all programmes offered by the university. TheProgram Outcomes, Program Specific Outcomes, and Course Outcomes have been predefined in all the programs. This provides a comprehensive understanding to the students right from the beginning of the session as to what should be the primary focus. It helps them self-evaluate their performance at the completion of the programme.

The University teacher has been using ICT tools for teaching for the past several years and it has become a regular practice. The university has a license for office365, and faculty members and students are registered users of the same, providing all the facilities associated with office365. Students are given online assignments and quizzes, presentations taken offline and online, and teachers record their lectures and share the link with students.

The IQAC of the University conducted Faculty Training Programme for developing e-content and using e-resources during the year. Moreover, the Information Technology department of Mewar University too provided several refresher courses and faculty development Programmes for the teachers as well as students. The teachers are effectively using ICT-enabled tools like laptops, headphones, PPT presentations, virtual labs, YouTube links, econtents, and mobile applications (MS-Team, Google meet, Zoom and Google classroom, etc.), Delnet, Shodhganga, SWAYAM, and NDL, etc.

University has provided other resources for faculty members as well as students i.e. LCD Projector, Wi-Fi connection, LAN connection, Audio system, and Learning Management System. During COVID-19, online classes were conducted for the students who could not come to classes offline following the COVID-19 guidelines. Online examinations were also conducted for final-year students. The university motivates the faculty members and students to do courses online on NPTEL SWAYAM and the credits earned are added to the student's credits earned at university examinations.

#### 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

The university has been following students centric methods, such as experiential learning, participative learning, and problem-solving methodologies for enhancing learning experiences. The Mewar University implements a two-way Teaching Methodology that helps students boost their confidence, and improve listening, writing, and public speaking skills. Since students vary in their ability to comprehend and absorb the subject knowledge uniformly, the teaching methodology adopted by the university helps in achieving better learning outcomes. The teacher facilitates learning by allowing each student to comprehend at their personal level by ensuring their involvement in-class activities to absorb and grasp information at their own pace. Experimental learning is practiced in the form of Lab activities, short-term training, internship, and industrial and field visits. Students are given problems in the assignments, and case studies in which they have to utilize their analytical skills to solve them. Various problem-solving methodologies such as group discussion, listing possible solutions to a problem at hand, and brainstorming is being implemented in all programmes offered by the university. TheProgram Outcomes, Program Specific Outcomes, and Course Outcomes have been predefined in all the programs. This provides a comprehensive understanding to the students right from the beginning of the session as to what should be the primary focus. It helps them self-evaluate their performance at the completion of the programme.

The University teacher has been using ICT tools for teaching for the past several years and it has become a regular practice. The university has a license for office365, and faculty members and students are registered users of the same, providing all the facilities associated with office365. Students are given online assignments and quizzes, presentations taken offline and online, and teachers record their lectures and share the link with students.

The IQAC of the University conducted Faculty Training Programme for developing e-content and using e-resources during the year. Moreover, the Information Technology department of Mewar University too provided several refresher courses and faculty development Programmes for the teachers as well as students. The teachers are effectively using ICT-enabled tools like laptops, headphones, PPT presentations, virtual labs, YouTube links, e-contents, and mobile applications (MS-Team, Google meet, Zoom and Google classroom, etc.), Delnet, Shodhganga, SWAYAM, and NDL, etc. University has provided other resources for faculty members as well as students i.e. LCD Projector, Wi-Fi connection, LAN connection, Audio system, and Learning Management System.

During COVID-19, online classes were conducted for the students who could not come to classes offline following the COVID-19 guidelines. Online examinations were also conducted for finalyear students. The university motivates the faculty members and students to do courses online on NPTEL SWAYAM and the credits earned are added to the student's credits earned at university examinations.

The research activities are governed by a set of norms formulated by the University Research Advisory Council. The University also has subcommittees such as a Research Board, Research Ethical Committee, and Bio-safety subcommittee to implement the research policies.

The University has established Research Centers to raise the research profile. University has established Nanotechnology Research Laboratory to promote research in nanoscience and technology. Nano Oxides and nano ferrites are synthesized and investigated to find their applications.

#### 3.3 - Innovation Ecosystem

The faculty members of the university involved in the consultancy are referred to as consultants and any other outside agency seeking consultancy is referred to as the beneficiary. Recently faculty members have undertaken a project from the textile industry and working on the reduction of water requirements in various textile manufacturing processes.

The University promotes active collaboration with the Public and Private sectors and NGOs. Faculties are motivated to undertake industry-oriented projects.

The university is following well-established systems & procedures at every level for the maintenance and utilization of resources

At the start of the new session, the Maintenance committee asks requirements of all the departments of the university regarding laboratories, libraries, sports, maintenance of classrooms and electrical equipments. Every HOD prepares a requirement list and submits to the maintenance committee for procurement of consumable items, new requirements or maintenance, and forwards it to the Store charge, from where all purchasing if required took place.

In every laboratory, Stock registers are maintained for keeping all in/out entries of goods purchased/issued/exhausted etc. Before starting of session every faculty performs all experiments in advance so that any non-functioning equipment can be repaired in advance.
