## SCHEME OF FIRST AIU ALL INDIA INTER - VERSITY WOMEN STUDENTS COMPETITION

## 1. Objectives of the Youth Parliament Scheme

AIU acknowledge that women's empowerment is both human rights and is essential for attaining comprehensive and sustainable development of human race. To address barriers to active participation of women in pursuit of constitutional establishments, The Association of Indian Universities took an auspicious initiative and introduced " ${ }^{\text {st }}$ AIU National Women Student Parliament" competition in University Sector. This will surely ensure for strengthened role of Women in the roots of democracy, inculcate healthy habits of discipline, tolerance of the views of others and to enable the Youth Girls student's community to understand the working of our Parliamentary institutions. It is being sensed that this inventiveness by Association of Indian Universities will bring a spark in the women to galvanize the young girls of the nation

With a view to strengthening the role of Women Empowerment in the roots of democracy, inculcate healthy habits of discipline, tolerance of the views of others and to enable the Youth Girls students community to understand the working of our Parliamentary institutions, the Association of Indian Universities has introduced the All India Inter - Varsity Women Students Parliament Scheme for Universities/Colleges throughout the country. These competitions will be conducted on an annual basis in each academic year. The First Competition being organized by the Mewar University at Chittorgarh (Rajasthan).

## 2. Eligibility for entry in the Competition

All the Universities/Colleges recognized by UGC/Government of India/State Government who sponsor their nominees for attending the Orientation Course conducted by the Organizing University on behalf of the Association of Indian Universities in collaboration of the Ministry of Parliamentary Affairs prior to the start of the Competition will be eligible for participation. All the Rules of the Association of Indian Universities will be applicable for this Competition. The Ministry of Parliamentary Affairs is being requested as Knowledge Partner of this All India Inter - Varsity Women Students Parliament Competition for Universities/Colleges.

## 3. Format and period of the Competition

National Women Parliament Will Be Conducted At Four Levels: -

## ROUND 1- DIGITAL

## ROUND 2- QUARTER FINAL

## ROUND 3- SEMI FINAL

## ROUND 4- GRAND FINALE

## Round 1 (Digital: Off Campus):

a) Universities have to send the videos of their 3 Participants (Team Members) within 120 seconds each to the host University (Video must be uploaded on the YouTube) then shall be sent on the Competition's website http://mewaruniversity.org link of the AIUWOMEN PARLIAMENT or Email: aiuwomenparliament@mewaruniversity.co.in.
b) 50 teams of different Universities will be shortlisted by the penal of ( 3 member) Jury on the basis of their videos from all over India for Quarter - final round.

## Round 2 for 50 Teams (Quarter Final: At Host University Venue):

a) 25 teams of different Universities will be in government and 25 Universities in OPPOSITION by draw.
b) In this round each team (Any One speaker from each team) will be given 3 minutes to speak on the selected bill. (Topic of the House)
c) At the end 10 Teams from the Government and 10 teams from the Opposition will be shortlisted by Jury for the semi-final round (Round 3).

## Round 3 for 20 Teams (Semi-Final: At Host University Venue):

a) The Semi Final Round at Host University will be a parliamentary debate round where 2 teams will face off each other and pair will be declared by the speaker for debate.
b) 2 minutes will be given to each member of both the teams i.e. Government \& Opposition. (Total 12 Minutes will be given to both teams- 6 minutes to each team)
c) 3 minutes will be given for the Direct Interjection.
d) After 15 minutes (Total time of point $\mathrm{B} \& \mathrm{C}$ ), remaining 30 teams (the teams other than 20 teams qualified for Semi Finals) will be given 10 minutes for the Questions \& Answers.
(The jury member will pick the team from the remaining 30 teams for question and Speaker will select Government/Opposition team to reply the question).
e) These Teams will choose the house for the questions; whether they ask question to the Government house or the Opposition house.
f) On the basis of quality \& impression of the question \& answer; speaker will give bonus marks to these teams.
g) Remaining 30 teams will compete for the fourth position for all rounds.
h) Sequence of the question will be based on either buzzer system or by sequence of question given by the speaker.
i) Team with the third highest marks will be the third position winner.

Note: There will be total 10 debates in Round 3 (Semi Final).

## Rules \& Regulation for Round 3:

- A coin toss will be held between the two teams. The winner of the coin toss will decide whether to be "The Government" or "The Opposition".
- The Prime Minister of the Government will pick a motion from the raffle box randomly.
- The Government will speak FOR the motion and The Opposition AGAINST the motion.
- The First Speaker will be The Prime Minister of the Government.
- The Second Speaker will be The Prime Minister of the Opposition.
- The Third Speaker will be The President of the Government.
- The Fourth Speaker will be The President of the Opposition.
- The Fifth Speaker will be The Whip of the Government.
- The Sixth Speaker will be The Whip of the Opposition.
- The Judges will judge both teams on the basis of their Content, Logic and Presentation skills.
- The two-best teams with the highest points will win the Semi Final and will head to The Grand Finale round.


## Round 4 (Final Round):

a) In the Final round, the same pattern of debate will be followed as earlier, with the addition of Question and Answer round by The Panelists (by other remaining teams from Semi Final round).
b) The winners of the Final Round will be the Overall Champion of the National Women Students Parliament.
c) The other team will become the First Runner Up.
d) Remaining teams will also get the chance to put forward their points; one point will be awarded for each (Marks will be given by Speaker and Jury only).
e) From remaining 30 teams, the team with the highest marks on the basis of the questions will get the consolidation prize.

## 4. Duration of the, "All India Inter - Varsity Women Students Parliament sitting."

The duration of the sitting of the, "All India Inter - Varsity Women Students Parliament" Each Participants will be granted 3 Minutes to speak of the motion. Out of this, nearly 2 minutes may be devoted to Questions and the remaining time be utilized for discussion on Bills, Motions, Resolutions etc. as indicated in the literature on the subject which would be made available during the Manager Meetings at the Host University by the AIU and Ministry of Parliamentary Affairs prior to the commencement of each Competition.

## 5. Subjects for discussion in the "All India Inter - Varsity Women Students Parliament Session."

The matters raised in the, "All India Inter - Varsity Women Students Parliament sitting." may relate to subject of welfare activities, defense, social reforms, economic development, communal harmony, public health, education, internal security, use of modern technology etc. Special emphasis may lay on issues relating to human rights, health and education. A list of suggested topics on which items may be presented is at Annexure-A.

No direct or indirect remarks may be made in the speeches which may cast aspersion on political parties or leaders/persons etc. and controversial topics based on actual events of recent occurrence should be avoided. It would be desirable to take up issues, based on hypothetical events for expounding upon the basic principles proposed to be debated. A list of "Do"s and Dont" $s$ "elucidating the various points to be kept in mind during the conduct of the „Youth Parliament Session" is given at Annexure-B.

## 6. Language

The participants may speak in Hindi/ English at Zonal and National Level. However at State Level the participants may speak in their Local Language

## 7. Venue

National Competition will be organized at Mewar University, Chittorgarh, Rajasthan.

## 8. Evaluation of the Competition at the National Level

At the National Level Competition the performances of each team would be evaluated by a panel of judges consisting of:
(i) Member of Sitting Women Parliament/Ex- Women Member of Parliament;
(ii) An Officer of the Ministry of Parliamentary Affairs; and
(iii) An academician of repute from a non-participating Universities preferably in consultation with the Organising Secretary of the Organising University/ /Association of Indian Universities/ Ministry of Parliamentary Affairs.

Based on this evaluation a merit list will be drawn to select the, "All India Winner". Individual performances will also be evaluated and prizes awarded to the selected team members on the basis of their meritorious performance.

## 9. Shields, Trophies, Prizes etc.

At the National Level the following would be awarded:

## (a) Running Shield

A running shield will be awarded to the Universities declared as first at the National level competition. The Running Shield will be awarded by the Mewar University and will be named as per the decision of the Chair Person/Chancellor of the Mewar University.

## (b) Trophies

i) The University declared as Second in the National level competition will be awarded another trophy.
ii) One trophy each will be awarded to the other Universities participating in the National level by virtue of their having secured First and Second position in their respective Zone in the first stage (group-level) of the competition.

## (c) Prizes and Certificates

i) Prizes and Certificates will be awarded to the students selected by the evaluating panel for their meritorious performances at the Digitization level competition.
(d) At the Digital Round the Zone Level of the competition, besides a certificate to the coordinator, a maximum of 6 (Six) students from among the members of the team of each participating Universities may be selected for award of individual prizes and certificates by Association of Indian Universities on the basis of the Digital round :-
i) First prize - One
ii) Second prize - One
i) Third prize - One
iv) Special prize - Three

## 10. Prize Distribution Function

The Prize Distribution Function will be organized in consultation of the Association of Indian Universities and Ministry of Parliamentary Affairs at a suitable date and venue after the competition is completed. At the function, the running shield, trophies to the Universities and prizes and certificates to the students at the National level will be awarded. The Universities which stands first at the National level will be required to give a repeat performance of their "Parliament Session" before a selected audience at the Prize Distribution Function. The duration of this, "Parliament Session" should not exceed 55 minutes.

The Organising University in consultation of the Ministry of Parliamentary Affairs and Association of Indian Universities will fix a date and venue for the function as mentioned in Para 3 of the scheme under the sub-heading calendar of events. The prizes shall be distributed by a high dignitary. Invitations to VIPs and others for attending this function will be issued by the Organising Universities in consultation with the Association of the Indian Universities and Ministry of Parliamentary Affairs.

The Prize Distribution Function would be attended by the Prize Winning students and the respective teacher-in-charge of the Universities which participated at the National level.

## 10. Travelling and Dearness Allowances.

The TA/DA to the students will have to be borne by the respective Universities.

Note: The above-mentioned requirements are tentative and can be changed on the need basis. Host University may engage a greater number of manpower or additional facility for successful conduct of the AIU NATIONAL WOMEN STUDENT PARLIAMENT.

## ANNEXURE-B

## DO'S AND DON'T FOR THE PARTICIPANTS IN THE YOUTH PARLIAMENT COMPETITIONS

1. The University and students participating in the AIU Women Student Parliament Competitions should bear in mind that this scheme is a unique one. It is aimed to make these University's Girls Youth Parliaments as the nurseries of future parliamentarians. If rightly implemented and its organizers and imbued with a sense of duty and dedication, it is likely to pay rich dividends in the shape of all round improvement in our national character and Women Empowerment outlook. This aspect should always be kept in view while the Universities/Colleges volunteer themselves for participation in these competitions.
2. It should not be forgotten that democracy offers political methods by which every citizen has the opportunity of participating through discussion and debates in an attempt to reach a voluntary agreement as to what should be done for the good of the community as a whole. It precludes the method of arriving at a decision on social policy in the streets as these are the ways of monocracy and not of democracy. Thus the scheme of AIU Women Student Parliament Competitions would help to start a movement amongst Women Student of the Universities/Colleges to channelize their energy into healthy and constructive activities so that they may become useful citizens of tomorrow for the cause of Women Empowerment in the World.
3. The subject to be selected for discussions in these AIU Women Student Parliament Competitions should be as far as possible non-controversial. They should largely deal with the problems confronting the educational institutions and their day to day problems. The subject should relate to welfare activities, define of the country, social justice and social reforms, economic development, communal harmony, discipline, health of the students, Human Rights etc.
4. Two most important parts of the list of business of a AIU Women Student Parliament Competitions " are the "Questions" and the „Debate" or „Discussion". During Question Hour, the judges are likely to be impressed by quality of questions asked and the quality of replies given by the Ministers. During the Debate or Discussions, they particularly look for the standard of Debate and the quality of expression.
5. The participants should scrupulously avoid mention of the existing political parties and political personalities in the country. They should give imaginary or fictitious names to their parties and personalities. They should not give any impression that they have any leanings or bias for or against any political party or philosophy.
6. It would be in the interest of the participating Universities if they were to have their own Women Student Parliament Competitions" which should serve as the "debating societies" for promoting debating talents in their students. Thus, at the time of selecting the names of participants they can draw upon the talent from these "Parliaments".
7. The participants should show utmost respect to the Chair. They should abide by the decisions of the Chair and should have faith in his impartiality and judgments.
8. Every member while coming to the House for its sitting should bow to the Chair and similarly while leaving the Chamber bow to the Chair.
9. The members should not say or do anything on the floor of the House that is not warranted by rules of procedures or by the ruling or precedence or by the accepted and established customs and conventions of the House.
10. There should be no discussion on sensitive policy matters affecting the relations of our country with foreign friendly Governments or which will prove embarrassing for the country and its present day Government.
11. A member should never cross the floor while the House is sitting i.e. he should never pass between the Chair and any member who is speaking. Violation of this rule is regarded as a breach of Parliamentary etiquette.
12. Members should not sit with their backs to the Chair. When a member wants to speak he should raise hands to attract the attention of the Chair. No member should speak unless he or she has „Caught" the eye of the Speaker and has been permitted by the Chair by name or by a sign, to speak.
13. Every member should resume her seat as the Speaker rises to speak or calls out "orderorder" and also when any other member is in possession of the floor. Two or more members should not keep standing at the same time.
14. No member should rise or leave the House when the Speaker is addressing the House. "The Speaker is always to be heard in silence".
15. No member should read out a written speech. However, a member may feel free to consult his notes whenever she losses track of his prepared speech or text.
16. Personal references by way of imputations or questions against the bonafides of any member should not be resorted to. A member must not address individual members of the House. She should always address the Chair and make all remarks to other members through the Chair.
17. Members should not distribute within the precincts of the House or inside the legislature questionnaires or pamphlets not connected with the business of the House.
18. The member during participation in the discussion can use either English or Hindi. However, if a member wants to speak in any other language, she is supposed to do so with the permission of the Speaker, but before speaking she is supposed to furnish in advance a copy of the translation of his speech in Hindi/English.
19. In short all participants in these Youth Parliaments should so conduct themselves as to inspire respect for Parliament and Parliamentary Institutions.
